#### Part I

# **Problem Statements**

### **Border Security**

#### **Total Governmental Expenditures on Illegal Aliens**

Currently, illegal immigration cost American Taxpayers upward of \$134 Billion. O'brien & Raley (2019) noted, "At the federal, state, and local levels, taxpayers shell out approximately \$134.9 billion to cover the costs incurred by the presence of more than 12.5 million illegal aliens and about 4.2 million citizen children of illegal aliens. That amounts to a tax burden of approximately \$8,075 per illegal alien family member..." This equates to over \$365 Million per day. This cost is passed on to taxpayers and is a result of unsecured borders. We are hemorrhaging taxpayer dollars over illegal immigration!

Further, the amount of people crossing our borders illegally has increased and passed the numbers for both FY17 and FY18 and is on target to possibly hit 1 million people by the end of FY19. Currently, without a report of August 2019 numbers, the U.S. has seen 760,370 apprehensions, with two months reporting remaining for FY19 (CBP, 2019). Note, the previous number represented the Southwest border (Texas) only.

## Southwest Border Migration FY 2019




Figure 2. Number of illegal immigrants apprehended at Southwest Border.

In addition to the enormous cost factors associated with an unsecured border, American citizens have to contend with the followings as well:

- Ranchers & Farmers hit with the cost of illegal immigrants property violations (Wagner, 2017):
  - Fences Destroyed
  - o Irrigation Lines Cut
  - o Property damaged and stolen
- Women and girls at put at great risk trying to cross into America illegally (Fleury, 2016):
  - According to Amnesty International, 60% of migrant women and girls are raped while migrating, while other data indicate that 80% of women experience rape and sexual assault during the migration process.
  - Given the frequency of sexual and gender-based violence, many migrant women take contraceptives before migrating to avoid the risk of pregnancy from rape by armed criminal groups, locals, or their smugglers.

- Unfortunately, contraceptives don't protect women from sexually transmitted diseases or other health risks, and migrant women often do not report or seek medical care for sexual and gender-based violence.
- Migrant women captured by criminal groups are also in danger of being sold into prostitution and human trafficking.

Overall, whether it's the negative economic impact, cost to our farmers and ranchers, risk and attacks on women and girls, loss of life on the journey, etc., securing our border becomes a deterrent and a benefit to American citizens.

### **Asylum**

Many asylum claims accompany the apprehensions, however, the overwhelming majority proved to be illegitimate. According to acting Homeland Security Secretary, Kevin McAleenan, 90% of those claiming asylum miss their court dates after being released into the US (Tacopino, 2019). Unfortunately, the overwhelming majority of people are not even attempting to enter America through one of the 328 legal ports of entry to claim asylum as seen by the 396,579 (70%) apprehension between the ports of entry (CBP, 2019). This indicates a broken system.

Further, the backlog continues to grow at a pace that cannot be reasonably addressed as the system is currently operating. In November 2018, there were around 809,000 pending cases on the U.S. immigration court's docket (Earl, 2019) and asylum seekers are waiting an average of 1000 days before their cases to be reviewed in an immigration court. This equates to those who often enter illegally being in the U.S. almost 3 years on the American Taxpayer dollar before a decision is made and in 65% of the cases in FY18, they were denied (Earl, 2019), about the same rate as FY2017.




Figure 4. Asylum Denial Rates 2000-2017. Source: Trac Immigration

Further, in FY2018, less than 10% of those entering the country claiming asylum, entered through one of the 328 legal ports of entry (CBP, 2018). Therefore, it is clear that the overwhelming majority of those entering the country illegally are not coming for asylum reasons as the media portrays. Ultimately, as this continues to cost American taxpayers and put our nation at great risk.

### Second Amendment

"Mass shootings; Gun Control; Assault Weapons"...are catchphrases that trigger emotions of people who would prefer guns are removed from the hands of the average American. Such people say there are too many guns, too many shootings, too many people dying, etc. Sure, one life lost to gun violence is one too many, yet things must be put into perspective. Using the AR-15 for example, which anti-gun advocates love to highlight as an assault weapon, a comparison will be made. Consider the death statistics from guns (Ar-15) vs. other methods, and ask why one narrative gets more scrutiny and the other more support than the other on a national platform:

- 1,670 children died from abuse or neglect in FFY 2015 average 4.5 per day. National Child Abuse and Neglect Data System (NCANDS)
- 1,604 people killed with "knives or cutting instruments." FBI: UCR Table 12
- 656 people were beaten to death with "hands, fists, feet, etc. Average 1.7 deaths per day. FBI: UCR Table 12
- 374 people were shot and killed with rifles (of which AR-15 included). Average 1.2 death per day. FBI: UCR Table 12
- 926,190 legal induced abortion deaths were reported by Guttmacher per year.
- 2,537 abortion deaths per day in the US. Guttmacher, 2014
- Of the 30,000+ Deaths with Firearms, 20,000+ are suicides (which are associated with mental health issues).




Figure 6. United States Gun Deaths. Photo Credit: Daniel Nass. Source: The Trace

Whether it is the AR-15, a handgun, long gun, etc. the number of deaths by shootings versus other means does not match up to the media firestorms about guns. Specifically, many of the ways people die, as listed above are rarely discussed in such a context of mass killings. The Second Amendment Right is just that, a 'Right' and must be protected.

## **Protecting Life of the Unborn**

According to the CDC (2019), during 2015, 638,169 legal induced abortions were reported from 49 reporting areas. The abortion rate for 2015 was 11.8 abortions per 1,000 women aged 15–44 years, and the abortion ratio was 188 abortions per 1,000 live births. That equates to:

- 1,748 babies killed per day.
- 72 babies killed per hour.
- 1.2 babies killed per minute

Those who could easily be deemed the most innocent among us are also the most vulnerable, the unborn. Yet they are being killed and disposed of at such an alarming rate. Research showed the following:

- In 2015, unmarried women accounted for 86% of all abortions (CDC).
- Adolescents under 15 years obtained .03% of all 2015 abortions; women aged 15–19 years accounted for less than 10% (CDC).
- Black women were more than 3.5 times more likely to have an abortion in 2015 than white women (CDC).
- Etc.

At a glance, being unmarried, 20 years or older, and/or black races the chances of a woman getting an abortion tremendously. Also, contrary to what is promoted, people are getting abortions, not simply because of the woman's right to do what she

wants with her body, instead here are the documented reasons (Finer, Frohwirth, Dauphinee, Singhand, and Moore, 2004):

#### **Percentage Reason**

<0.5%	Victim of rape
3%	Fetal health problems
4%	Physical health problems
4%	Would interfere with education or career
7%	Not mature enough to raise a child
8%	Don't want to be a single mother
19%	Done having children
23%	Can't afford a baby
25%	Not ready for a child
6%	Other

So, the top three reasons for killing an innocent baby is the woman is *done* having children, can't afford a baby, or not ready for a child, therefore the child is killed and discarded. This is unacceptable.

### **Small Businesses**

### Energy (Oil / Gas)

All estimates of America's oil and natural gas reserves indicates they are plentiful and will be for generations to come. Considering the prolific Permian oil and gas basin that straddles Western Texas and Southeastern New Mexico, for example, the United States Geological Survey (USGS) estimates that over 46 billion barrels of oil, 280 trillion cubic feet of gas, and 20 billion barrels of natural gas liquids are trapped in these low-permeability shale formations (Cohen, 2018).

However, opponents of the increased exploration of such resources, hinder retrieval of such them and the economic growth which accompanies it. Further, America encourages other nations to explore their coast while barriers continue to exist for exploration of its own. Many of the reasons opponents stand against increased exploration are anchored in environmental concerns. Some of the major concerns are as follows (TWS, 2019):

- 1. Drilling disrupts wildlife habitat.
- 2. Oil spills can be deadly to animals
- 3. Air and water pollution hurt local communities
- 4. Dangerous emissions contribute to climate change
- 5. Oil and gas development ruins pristine landscapes
- 6. Fossil fuel extraction turns visitors away
- 7. Light pollution is impacting wildlife and wilderness

Protecting the environment must always be of great concern, however, we must not lose balance and forgo opportunities at Energy Independence during the process. America has some of the brightest minds on earth so we must use them collectively to plan ways to achieve Energy Independence while protecting the environment. Being stagnant in such efforts will continue to cost the nation greatly.

### **Protecting Veterans**

The endless stories of veterans dying while waiting to receive care at V.A. facilities are sad and intolerable. As Devine (2015) notes, over 300,000 veterans may have died while awaiting V.A. Healthcare. The U.S. Government Accountability Office (GAO) designated VA health care as a high-risk area in 2015 due to five areas of concern regarding VA's ability to provide timely access to safe, high-quality health care for veterans: (1) ambiguous policies and inconsistent processes; (2) inadequate oversight and accountability; (3) IT challenges; (4) inadequate staff training; and (5) unclear resource needs and allocation priorities. In 2017, GAO reported that while VA had taken some actions to address these issues, little progress had actually been made (GAO, 2019).




Figure 11. U.S. Military struggling to stop suicide epidemic among war veterans. Source: The Guardian

Although those crucial deficiencies were noted, full-resolution has still not been attained 4 years later. As Lee (2015) noted, 18 to 22 veteran suicides a day and this must be addressed and resolved expeditiously. We must prioritize the mental health of veterans just as much as we do their physical health!

### Healthcare

Since the enactment of the Patient Protection and Affordable Care Act, often shortened to the Affordable Care Act (Obamacare), the healthcare debate has been at the forefront of debates and discussions. Obamacare was plagued with problems such as (Amadeo, 2019):

- 1. Americans (including experts) don't know its cost to the nation.
- 2. Health insurance companies canceled plans for 1 million people because they didn't comply with the ACA's 10 essential health benefits, therefore not allowing people to keep their plans as President Obama promised.
- 3. Between 3 million and 5 million people lost their company-sponsored health care plans as many businesses found it was more cost-effective to pay the penalty than provide health insurance benefits.
- 4. Consumers ended up with higher premiums because health care providers and health insurance companies ultimately paid additional taxes to help fund Obamacare's benefits and thus additional cost was absorbed by the people (insured).

Ultimately, what was slated to be a remedy for healthcare resolutions, has resulted in higher healthcare costs, fewer choices for care for the average person, exploding Medicaid enrolments with fewer choices for the enrolees, etc. (Moore, 2018).

Overall, Obamacare has driven up premiums and deductible costs for individuals, families, and businesses and forced people off the plans they liked. Further, it has fuelled waste, fraud, and abuse. Such issues must be rectified for the American people.

# **Education**




Figure 13. U.S. Education Challenges. Photo Credits: Adam Vagley. Source: Expat

As such it will begin to see the long-term effects of such shortcomings. Desilver (2017) highlighted, "Recently released data from international math and science assessments indicate that U.S. students continue to rank around the middle of the pack, and behind many other advanced industrial nations." We are not a middle of the pack type of nation, we are a leading nation and we must resume doing so on the Education front as we do in many other areas.

As recently as 20 years ago, the United States was ranked No.1 in high school and college education (Randolph, 2019). Although the United States still ranks No.1 in the world's higher education institutions (i.e., colleges) the ability to help graduates transition into the job market, it has experienced a tremendous negative downturn in ranking for primary education. Due to complacency and inefficiency, reflective of lower priorities in education, and inconsistencies among the various school systems, America's schools have witnessed a decline. In 2009, the United States was ranked 18th out of 36 industrialized nations (Randolph, 2019). Such a mediocre ranking is not acceptable for the greatest nation on earth.

Further, issues stated above have a negative impact on the children, which in turn on the communities and ultimately, the nation. Lastly, consider the pay challenges, day to day stresses with educators, and the fact that more than a million teachers don't have Social Security to fall back on (Turner, 2018) and America's public education system is one subject to imminent collapse in the future.

# <u>Infrastructure</u>

When thinking of America's infrastructure, one may often think of roads and bridges (though it is much more). Considering roads and bridges nevertheless, great undertakings and infrastructure projects on a mass level haven't taken place since the New Deal under President Franklin Delano Roosevelt. The New Deal converted dirt roads to concrete ones, built airports and brought electricity to all corners of the nation (Wharton PPI, 2017). Over the past several decades since that time, America has seen the number of automobiles on the roads drastically increase and with them, an increase of wear and tear on those roads and bridges. Unfortunately, keeping up repairs on them is endless and today we have many bridges (and roads) that are in dire need of replacement.

Allowing them to remain in their current condition cost Americans greatly. As Ferguson (2018) noted, "America's roads and bridges cause issues that range from the small daily inconveniences of longer commutes to safety concerns and economic burdens." Infrastructure problems cause other issues such as (Ferguson, 2018):

- 1. <u>Traffic Congestion</u> In 2014, traffic congestion wasted 6.9 billion hours of motorists' travel time and almost 3.1 billion gallons of fuel.
- Consumer Cost Driving on poor roads cost motorists roughly \$112 billion in additional repair and operating costs annually.
- 3. <u>Risk</u> Americans take over 200 million trips daily across deficient bridges in the 102 largest metropolitan regions.

Even more concerning is the unnecessary cost of life due to such poor roads and bridges. The U.S. roads infrastructures received a D rating in the most recent American Society of Civil Engineers report and the poor infrastructure has led to an increase in traffic fatalities by 7% from 2014 to 2015. We must not continue to take such risk and put Americans in harm's way when such things are avoidable.

Beyond roads and bridges, more work has to be done with respect to other areas of infrastructure. Consider the below-average grades for U.S. infrastructure below:

# Farming/Ranching

Farmers have undoubtedly faced their share of challenges since the Trump Administrations trade war with China. Today, our farmers still have some barriers in place which makes it more difficult to sell their products to our northern neighbors, Canada, and southern neighbors, Mexico. Currently, they are America's largest trade partners with \$4 billion a day of trade between the three countries.

According to the AFBT (2019), "The required International Trade Commission economic impact report on USMCA was released on April 18, 2019. It projects that USMCA, when fully implemented, will add \$2.2 billion to the amount of agricultural and food exports to Canada and Mexico." This is a windfall of economic resources that help both the farmers and the American people. Regulations, however, which hinder such trade, do not help farmers during a time they need it the most, and also hinder such expansion and increase.

Further, farmers and ranchers want to be able to make decisions about managing their land and water resources without uncertainty or time-consuming and expensive red tape as existing with cumbersome regulations. Such hindrances must be addressed and rectified.

### **Social Security**

Mention *Social Security* and many things can ensue from discussions, disagreements, concern, frustration, anxiety, etc., most -- simply not good. At hand is many people who have paid into *Social Security* for years and are not sure if it would be around for them to reap the benefits and collect a check. Workers and employers pay for Social Security. Workers pay 6.2 percent of their earnings up to a cap, which is \$127,200 a year in 2017. (The cap on taxable earnings usually rises each year with average wages.) Employers pay a matching amount for a combined contribution of 12.4 percent of earnings (NASI, 2019).

Unfortunately, those paying into the system today may never recoup the amount paid in. According to Luhby (2013), "Couples now in their early 40s will have forked over \$808,000 in Social Security taxes by the time they retire, but get back only \$703,000 in benefits." This is discouraging, especially during a time whereby, the future existence of Social Security is in question. Many problems exist with the Social Security system as is, however, two stand out and must be addressed immediately (Williams, 2018):

 A falling worker-to-beneficiary ratio – more people collecting versus fewer working and paying into the system.


2. **Rising life expectancies** – people are living longer which means they can collect more benefits.

Americans simply want to know, when I am retirement age after I have paid into Social Security for years, will there be a fund of which I can draw financial benefits. Such a concern is valid and must be addressed and resolved.

# **Protecting Religious Freedoms**

Although a recent survey conducted by pew research shows over half of U.S. adults have a belief in the God of the Bible, religious freedoms as a whole are still under attack. Dougherty (2018) highlighted the issue as follows:

"Our Constitution was made only for a moral and religious People," John Adams wrote, "It is wholly inadequate to the government of any other."

Well, Americans stopped being a "religious People" quite a long time ago. And they are becoming progressively less attached to organized religion by the day. Consequently, the accepted meaning of the First Amendment has been changing. And the Constitution is becoming inadequate for the defense of religious people and their institutions.

Whether its people threating to boycott Chick-fil-A because of their support for anti-LGBTQ groups or the city of San Antonio, TX not allowing the chain to operate in the city's airport, the attack on religious freedoms is clear. Considering the last example, Del Valle (2019) noted how the San Antonio City Council decided to remove a proposed Chick-fil-A location from its airport concession agreement, because of this businesses' "religious beliefs and moral convictions, including beliefs and convictions regarding marriage."

Chick-fil-A is among many businesses that have been targeted due to their religious stances. America will not be the prosperous, free nation that we have come to know if such blatant attacks are allowed to continue. Greater than the attacks on businesses is the attack on Religious Freedoms taking place in the Halls of Congress. Currently, there is a push to pass what is dubbed the "Equality Act". Currently, Title VII prohibits employers from making employment decisions based on an individual's "race, color, religion, sex, or national origin." The *Equality Act* would replace the word "sex" with the phrase "sex (including sexual orientation and gender identity)." Here are a few problems with this Act (Burke, 2019):

- 1. It would penalize Americans who don't affirm new sexual norms or gender ideology.
- 2. It would compel speech.

- 3. It could shut down charities.
- 4. It would allow more biological males to defeat girls in sports.
- 5. It could be used to coerce medical professionals.
- 6. It could lead to more parents losing custody of their children.

This is not an exhaustive list, but if it sounds shocking, it should. Unfortunately, these issues are already arising across the nation and will explode if such legislation is passed. We must stand with religious freedoms and for our Constitution by protecting such rights.

### **Border Security**

Border Security has been in the spotlight more prevalent in recent years than in the past and is one of the most pressing, volatile, topics in modern times. Such a topic is sure to stir up debates, but must be addressed soon from a congressional perspective in the greatest efforts to provide resolution. To start, we must:

- Advocate for, and increase the number of Border Agents.
- Advocate for General Schedule (G.S.) workers to operate within Customs &
  Border Patrol, for the purposes of processing and overseeing children /
  unaccompanied minors, which will free up agents to be in the field. Such
  G.S. workers could come from a pool of recently, honorably discharged
  veterans looking to transition into the civilian sector but still serve.
- Ensure funding is provided for more and better technology and equipment for our CBP Agents.
- End any form of catch and release.
- Implement harsher penalties for those entering the country illegally.
- Fight to ensure the U.S. Constitution is upheld. Article 4, Section 4 states, "The United States shall guarantee to every state in this union a republican

form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

- Ensure Border Patrol Agents are authorized over time which will help against high levels of attrition.
- Provide better incentives to retain Agents and increase family readiness such as better education options for children of Agents in areas of low performing schools.
- Promote legislation to navigate beyond environment issues on the border preventing Agents from being more effective in doing their jobs.
- Increase the number of immigration judges.

Too many of our lawmakers are placing walls of protection around those who enter our country illegally, but provide no walls of protection and support for our U.S. Customs and Border Patrol Agents, who are both physically and verbally attacked all too frequently. Further, they are reluctant to provide proper funding for a physical barrier our Agents say will help support their efforts to secure our border. Whether Republican or Democrat, members of both the House and Senate swore or affirmed the same oath which states *they will support and defend the Constitution of the United States against all enemies, foreign and domestic;*.... Today, it is clearly under attack.

It's time we fight to place a protective wall around our nation as a whole, the U.S. Constitution, and spirit thereof, which has served us so greatly since September 17, 1787 (Amended as needed)! Stand with freedom, stand with justice, stand with America!

With over 800,000 immigration cases pending (many asylum cases), we must review and revise our asylum laws. I would push to do the following:

- 2. Establish a cap for asylum applications just as we have for refugee admissions (with flexibility for review of special cases beyond the cap as necessary).
- 3. Authorize temporary work authorization for asylum applicants after 180 days in the United States.
- 4. Ban anyone proven to have filed a frivolous application for asylum from applying in the future, any future opportunity to become a citizen or any possible guest-worker opportunities which may become authorized in the future.
- 5. Immediate deportation order and a lifetime ban from entering the country if asylum seeker fails to appear in court.

Overall, we have many things that must be done to bring better security to our border, save taxpayer dollars, help those seeking refuge in the U.S. who enter properly while accounting for illegal activity. There will continually be work to be done and improvements to be made, but we must start now!

As a strong advocate for gun rights and our Second Amendment as a whole, the following suggestions are foundational to legislation I would support and/or promote:

- Allow concealed license carriers to bear arms in schools, movie theatres, etc.
- Promote awareness and sharing. "Be Aware and Ready to Share!" information to stop gun violence. For Example, it's documented that 75% of lone wolves tell another person, usually a friend or family member, about their intentions or even post their plans on social media (Connor & Flynn, 2018).

• Understand death statistics from guns vs. other methods.

Although many reject the discussion of mental illness as associated with gun deaths in an effort to steer towards gun control, the fact remains that about two-thirds of gun deaths are due to suicide. As such, those deaths highlight the potential of mental illness being associated with such deaths. It is time to exercise forward-thinking and designate 1% of the annual federal tax dollars collected for firearm sales (\$123,000,000), which would be \$6,150,000 to mental health professionals' educational scholarships, fund public and private mental health opportunities for those under or uninsured, marketing, etc. to share opportunities for treatment of mental illness. The education factor will hopefully encourage people to enter the field and commit time in public sector offering services as the funds may also be earmarked to pay off student loans of those opting to work in the mental health public sector.

# Energy (Oil/Gas)




Figure 24. USGS Map. Photo Credit: Christoper Skinner. Source: USGS

  The latter will contribute to better service and a less stressful environment.
- 2. **Target Veteran Suicide** Prioritize filling the thousands of unfilled positions for doctors, nurses, mental health therapists, and any others on the front lines of helping lower the high rate of veteran suicides.
- 3. **Update Medical Records System -** VA's medical record-keeping system is antiquated which leads to greater potential for errors, whereby the veterans may pay the cost, even with their lives.
- Ensure Mission Act 2018 Is Fully Enacted The Veteran Community Care
  program allows certain Veterans to have more choices with respect to their
  healthcare and also allows for urgent care outside of the VA Healthcare
  system.
- 5. **Ensure the expedient release of ineffective leaders** those in leadership that prove to be inefficient and ineffective in carrying out their jobs.

6. **Ensure protection of Veterans Disability** – we must ensure veterans' disability benefits are protected now and in the future.

Overall, there must be a Veteran Focus – Veteran First mentality established with proper oversight of those not meeting the standards set for caring for our Veterans. This has to be coupled with the right of expeditious removal as needed to ensure proper accountability.

## **Healthcare**




Figure 26. Health Savings Accounts. Photo Credit: EBN Source: Benefit News

  - May allow options and other access to care.


- May allow more options as far as doctors are concerned as many refuse to take Medicare patients because of inefficient government reimbursements.

# Farming/Ranching




Figure 29. States with the highest employment level in this occupation. Photo Credit: Bureau of Labor Statistics.

## **Social Security**

Guaranteeing Social Security benefits for future generations will require several actions, many of which are tough but necessary such as follows:

- Increase the number of workers per retiree by continuing legislation favorable toward job creations.
- Help workers with disabilities remain employed so as to lower the withdrawals from the Disability sector of Social Security.
- Ensure that we curb illegal workers, many of whom are not paying into the Social Security System money that would increase funds for this benefit.
- Gradually raise the age for Social Security beneficiaries for those that will be at least 10 years from eligibility to receive benefits.

The *Social Security Act* was signed into law by President Roosevelt on August 14, 1935, whereby at 65 years of age a person could begin to draw this benefit. We must keep in mind that in the 1930s the life expectancy was only 58 for men and 62 for women, and the retirement age was 65 which meant that most people that could draw Social Security, would only do so for a limited time. However, today it is about 76 for a man and about 81 for a woman. So that has changed but the age for drawing benefits hasn't. Therefore, if we gradually raise the age for Social Security beneficiaries for those that will be at least 10 years from eligibility to receive benefits, this also help to ensure benefits for the future.

# **Protecting Religious Freedoms**



Among the constitutional freedoms listed by the founding fathers in the First Amendment, the restriction upon the government from interfering with religious expression comes first. The government may not limit this expression directly through regulation, indirectly through taxation or other power of government, nor may it use its spending power to promote or discourage any religion.

People of faith should be allowed to practice their faith freely as their holy books prescribe as long as it does not become a threat to the safety and welfare of our citizens. George Washington noted in his farewell address, "Of all the dispositions and habits which lead to political prosperity, religion and morality are indispensable supports..."
